Nellis AFB is a member of the United States Air Force's Air Combat Command and the home of the Air Warfare Center, the largest and most demanding advanced combat training missions in the world.

The 432nd Wing at Creech AFB is the Air Force's first remotely piloted aircraft systems wing. The 432nd Air Expeditionary Wing "Hunters" consists of combat-ready Airmen who fly the MG-1B Predator and the MQ-9 Reaper Aircraft to support United States and Coalition warfighters. The Hunters conduct remotely piloted aircraft system initial qualification training for aircrew, intelligence, weather and maintenance personnel.

The local area has low annual humidity of 20 percent and 310 days of sunshine (86 percent) with low annual rainfall of 4.13 inches. Summer day time temperatures average above 100 degrees while nights are pleasantly warm. Winter temperatures range from the mid-40's to the upper 60s. High velocity wind storms and accompanying dust storms occur occasionally.

Waitlist Eligibility Date & Bedroom Entitlement Determination

Waitlist Eligibility Date

The waitlist eligibility date of application will be determined according to the following criteria: **Advance Application-** Members ordered to active duty or to PCS to a new location may submit advance applications, effective date is the date the applicant departs the losing installation or the date order to active duty.

New Arrival Application – Members applying within 30 days of arrival, effective date will be the departure date from the losing installation.

Walk-in Application – Members applying thereafter will have an effective date of the application walk-in submitted date.

*Tip: Ensure an application identifies and includes all supporting documentation to include but not limited to impending promotion or gain of dependents to prevent delays in processing.

Bedroom Entitlement

Determining appropriate bedroom entitlement is based on the member's grade and family composition. Use the table that provides the most bedrooms unless the member voluntarily accepts less.

2. OFF-BASE HOUSING

Current tenants and individuals seeking to rent property should consider including a "Military Clause" in their lease agreement. This sort of clause would allow a tenant to terminate their lease upon providing a thirty (30) day written notice to the Landlord given Tenant receives permanent change of station (PCS) to depart from Premises. Current tenants would need to amend their current lease agreement and should seek the advice of a legal assistance attorney to ensure the amendment is legally sound. New tenants should simply demand the inclusion of a "Military Clause" before signing the lease agreement.

An example of a "Military Clause" is included with this memorandum for your reference. This example can be modified according to the desires of the tenant, but it is recommended that a tenant speak to a legal assistance attorney before adding to or departing from this example for one reason or another.

Military Clause Addendum

Service Members Civil Relief Act (SCRA)

IN THE EVENT the Tenant is or hereafter becomes, a member of the United States Armed Forces on extended active duty and hereafter the Tenant receives permanent change of station (PCS) orders to depart from the area where the Premises are located, or is relieved from active duty, retires or separates from the military, is ordered into military housing by their commanding officer, or receives deployment orders, then in any of these events, the Tenant may terminate this lease upon giving thirty (30) days written notice to the Landlord. The Tenant shall also provide to the Landlord a copy of the official orders, or a letter signed by the Tenant's commanding officer, reflecting the change which warrants termination under this clause. The Tenant will pay prorated rent for any days which he/she occupies the dwelling past the beginning of the rental period.

The damage/security deposit will be promptly returned to Tenant, provided there are no damages to the Premises.

Benefit and Protection No. 5 - Residential (apartment) lease terminations - 50 U.S.C. § 3955.

Section 3955 of the SCRA, 50 U.S.C. § 3955, addresses the topic of lease terminations. With respect to residential apartment leases, the SCRA requires that the premises be occupied (or are intended to be occupied) by a servicemember or a servicemember's dependent(s). 50 U.S.C. § 3955(b)(1). Additionally, the lease must either be executed by a person who later enters military service, or is in military service and later receives permanent change of station ("PCS") orders or deployment orders for a period of at least 90 days. <u>Id.</u> at § 3955(a)(1). To terminate a residential lease, the servicemember must submit a written notice and a copy of his or her military orders – or a letter from a commanding officer – by certain methods to the landlord or landlord's agent. <u>Id.</u> at § 3955(c) & (i)(1). If a servicemember pays rent on a monthly basis, once he or she gives proper notice and a copy of his or her military orders, then the lease will terminate 30 days after the next rent payment is due. 50 U.S.C. § 3955(d)(1). If a servicemember lessee dies while in military service, the spouse of a lessee may terminate the lease within one year of the death. Id. at § 3955(a)(3)


