

# POOL RULES

## I. STAFF

- 1.1 The pool is not under lifeguard supervision.
- 1.2 A Pool Monitor will make random spot checks during all operating hours to ensure pool rules are being followed, restroom facilities are clean and stocked, and to serve as a point of contact for patrons.
- 1.3 Pool Monitors are not required to have CPR and/or First Aid training.

## II. POOL

- 2.1 Maximum Capacity: 100
- 2.2 Hours of Operation: Sunday, Tuesday, Wednesday, & Thursday 10am- 7pm, and Fri & Sat 10am – 8 pm. Hours are subject to change when school is in session.
- 2.3 Water play structures will remain on during all operating hours.
- 2.4 Underwater pool lights will be turned on when the Pool Monitor performs the closing procedures and turned off the following morning by the Pinnacle maintenance staff.
- 2.5 At the discretion of the Pool Monitor, ten minute “Adult Swims” may be called. Adult swims may only be called when there are 30 or more people in the water. Only adults 18 years and older and toddlers/infants under two years old will be allowed in the pool during these times.

## III. MEMBERSHIP / ACCESS

- 3.1 There is no admission charge to use the pool.
- 3.2 You must be a housing resident at The Landings at Langley to use the pool and its facilities.
- 3.3 Each household is entitled to bring up to 2 non resident guests per pool visit. The resident is responsible for the behavior of their guests.
- 3.4 Single Airmen living in the barracks are not allowed in the pool or its facilities unless they are guests of a housing resident.
- 3.5 All patrons must provide a pool pass when asked by the Pool Monitor. If you do not have a pool pass when asked you will be asked to leave the pool. Pool passes can be obtained at the welcome center.
- 3.6 Family Child Care (FCC) Providers bringing children in their care to the pool must bring a certified lifeguard with them per FCC supervision rules.

## IV. POOL RULES

- 4.1 Children must be at least 14 years old to enter the pool area without an adult. They must have a special pool pass with their age listed and their parent’s signature.
- 4.2 Children under the age of 14 must be accompanied by an adult at least 18 years of age.
- 4.3 Each adult may supervise up to 3 children under the age of 14. This includes children under an FCC provider’s care.
- 4.4 Children who are not yet potty trained must wear a swim diaper to enter the pool
- 4.5 Appropriate bathing attire must be worn. Street clothes will not be allowed in the pool. Appropriate bathing attire consists of a swim suit top and bottom. Tank tops, shorts (not denim) and/or t-shirts may be worn over a bathing suit, but not instead of.
- 4.6 Patrons are encouraged to shower off before entering the pool.
- 4.7 No running on the pool deck.

- 4.8 No glass containers allowed in the pool facility.
- 4.9 No smoking in the pool facilities.
- 4.10 No alcohol in the pool facilities.
- 4.11 Patrons with open wounds or infectious diseases are not allowed in the pool.
- 4.12 No dunking, diving, rough housing or horseplay allowed in the pool.
- 4.13 No foul language.
- 4.14 No inappropriate touching, groping, kissing, etc. This is a family pool.
- 4.15 Music must be kept to a level where everyone can enjoy the pool.
- 4.16 Rafts, tubes, and floats are not permitted

## **V. DISCIPLINE**

- 5.1 Children under the age of 14 attempting to enter the facility without an adult will be turned away.
- 5.2 Anyone in violation of the above POOL RULES will be given the following discipline:
  - a. First offense – verbal warning
  - b. Second offense – removal from the pool for 30 minutes.
  - c. Third offense – will be told to leave the facility and pool privileges will be revoked for the season.
- 5.3 All rule enforcement is at the discretion of the Pool Monitor and the Property Management. Any behavior that disrupts the comfort and/or enjoyment of others will result in the resident being told to leave the facility.
- 5.4 Repeat offenders will be banned from the facility for an amount of time proportionate to the severity of the offense, ranging from 2 weeks to the entire pool season.
- 5.5 Base Security will be called for any patrons who become difficult, violent, belligerent, or inappropriate in any manner.

## **VI. SAFETY**

- 6.1 All steps entering the pool are nonslip surfaces. They have sturdy visible handrails on either side. Ladders or stairs are located at the shallow end and at both sides of the deep end of the pool.
- 6.2 The depth of water in the pool is plainly marked at points of maximum and minimum depths, at the break between the deep and shallow areas. The markers are at least 4 inches in height and of contrasting color and shall be located on both sides and both ends of the pool.
- 6.3 All deck areas shall completely encircle the pool, be ample in size, and allow for passage.
- 6.4 One set of lifesaving equipment is provided consisting of:
  - a. One or more poles at least one-half the width of the pool plus two feet, one having a shepherd's crook.
  - b. One U.S. Coast Guard approved throwing ring having minimum diameter of eighteen inches and equipped with one-quarter-inch line not less than one-half the width of the pool.
- 6.5 A 911 telephone is provided for emergency use.

## VII. RECORDS

7.1 A daily operation record of the circulating system, chemical additions, bather load, and chlorine and PH, are maintained for the pool facility.

7.2 The pH and chlorine residuals shall be monitored and recorded a minimum of three times daily and be performed during bather activity.

## VIII. POOL CLOSURE

8.1 Pool closure is required if:

a. There is inadequate recirculation or filtration, there is insufficient or excessive disinfectant, if the pool fails to meet other chemical standards, or if water clarity is lacking and the pool bottom is not visible from the pool deck.

b. The bottom drain plates or grates are not in place, not secured, or broken.

c. An unsafe pool condition is present, such as a broken electrical pool light or a chlorine leak.

d. Inclement weather.

e. A contamination including; fecal matter, blood, vomit and/or dead animal.

8.2 In the event of a pool closure, patrons will be required to clear the water immediately.

8.3 In the case of a **blood or vomit** contamination, a skimmer will be used to remove as much of the contamination as possible, the residual chlorine level will be raised, and the pool will remain closed for a minimum of **1 hour**.

8.4 In the case of a **fecal matter or dead animal contamination**, a skimmer will be used to entirely remove the contamination, the residual chlorine will be raised to a breakpoint level, and the pool will remain closed for **4 hours** to allow for one full filtration cycle. In the case of loose stool/diarrhea the pool will be super chlorinated and will remain closed for **8 hours**.
